Happy New Year All,

First, I want to thank all of you for another amazing year and the patience you have shown as we look for our next golf professional. We should have an exciting announcement for you all shortly!

The Annual range prices for 2022 have changed to the following: \$400(Public)/\$340 (Member) for individual, \$500(Public)/\$440(Member) for family, \$200(Public)/\$160(Member) for a junior, \$200 for a 25 bucket punch card and \$85 for a 10 bucket punch card. Please make your payment by the end of January for the New Year.

We will be hosting our 4<sup>th</sup> Annual New Year's Shootout on January 15<sup>th</sup>. This will be a 10am shotgun start. Front 9 is a two-person scramble and back 9 is a two-person shamble. Eight Stroke Differential between partners. \$65 per public player & \$45 per member.

Just a heads up . . . we will be switching our credit card processing company sometime in the next month. I

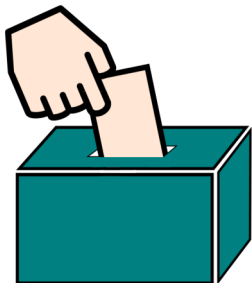
