- **Subject to Board Approval** – All memberships are subject to Board Approval and will be presented for approval at the next regular Board Meeting.
- **Cancellation and Refund Policies** – All resignations must be received in writing by the Club Administrator prior to the effective resignation date. Initiation fees and membership dues are non-refundable.
- **Payment Requirements** – Monthly dues payments are due by the 10<sup>th</sup> of the month. Payments that are 30 days past due will incur a \$25 late charge.
- **Dues Increases & Assessments** – Dues may increase any time during the year as per Board Approval. Property Tax Assessments are assessed to all Memberships except Student Memberships in the amount of \$100 on March 1<sup>st</sup> and September 1<sup>st</sup> annually.
- **Rules of Play** – All golfers must check-in at Pro Shop prior to play. Junior Golfers must complete an orientation before first play. Play begins on the first tee unless otherwise directed. Further rules to follow are in Member Handbook.
- **Acceptance/Release** – I acknowledge the conditions of membership stated above, for myself and on behalf of my family and/or guests included in my membership, if any. I hereby release Peninsula Golf Club, Inc., its agents, servants, and employees from all ordinary negligence, including all claims for injury, illness, death, loss or damage which may result from participation as a member. # Membership Application 2022-2023

## Membership Information:

**Certificated Equity Members** (Holders of Certificates of Ownership). An Equity Member is one whose application for membership has been approved and accepted by the Board, has paid the initiation fee of \$800 to purchase a Certificate of Ownership. Certificated members have the ability to serve on the board of directors and participate in voting of said Board, approval of the annual budget and are encouraged to participate in various committees. Additionally, members have the privilege of playing at any of our reciprocal golf courses, renting golf cart storage space, renting lockers on premises and having their dues processed automatically via banking ACH withdrawals.

**Non-Equity Membership:** Non-Equity Members are those whose application for membership has been approved and accepted by the Board and paid any initiation fee as determined by the board based on membership type. Additionally, members have the privilege of renting golf cart storage space, renting lockers on premises and having their dues processed automatically via banking ACH withdrawals.

**Associate Membership:** The conditions of an associate membership are: (1) approval of application for associate membership by the Board of Directors; (2) payment of an initiation fee; (3) a commitment of the new member to a minimum time of membership of eight months, but not limited to eight months, a written notice of resignation is required to terminate the membership. It is not done automatically. Dues and fees must be kept current on a monthly basis.

**Ninety (90) Day Members:** Ninety (90) Day Members are those Non-Equity Members whose principal residence is outside the State of Washington. The Board may approve a membership period greater than ninety days on an individual basis.

**Military Members:** Military members shall be active duty military. Members shall pay an initiation fee equal to one-half that otherwise applicable for an associate membership.

**Law Enforcement and Fire Protection Members:** These members shall pay the same as military members and shall be employed full-time in law enforcement or fire protection by a city, a county, a state, or the federal government. These members shall pay an initiation fee equal to one-half that which is otherwise applicable for an associate membership.

**Student Members:** Student Members are Non-Equity Members who are otherwise unrelated to any current Member of the Club and who have applied for and been accepted into Membership and paid all required fees and are full-time students under the age of 23. Membership is an annual membership and provides discounted greens fees for the student member.

**Junior Members:** Junior members are Associate members who are between the ages of 18 and 35.

## Reciprocal Information:

To book a reciprocal time you must call the Pro Shop at (360) 457-6501. Members pay the price of a power cart. The Pro or Staff will set up the time for you at the course you request to play at. All the courses except Gorge Vale require a power cart rental (two for each foursome).
