Notice to all members.

As the result of a member complaint to the state Attorney General's office and subsequent inspection by the Liquor Control Board, we have been fined for violating our Private Club liquor license for serving alcohol to a non member.

Although we are not pleased with the nature of the complaint and its results, we need to acknowledge this as a lesson learned and make every effort to abide by our Bylaws and be in compliance with our Private Club Liquor License.

This is not going to be easy, but until such time as we can work it all out it's our duty as members to protect and marshal our club and property.

A few basic rules to follow in accordance with our Private Club Liquor License and Bylaws:

- Members, guests, and non member/public are not allowed to bring alcohol on our property for consumption.
- Guests, non-members/public are not allowed to consume alcohol on our property unless purchased from us and they are signed in and accompanied by a member.

The Board of Directors is diligently working on this matter and the nature of the complaint. We will keep you informed as we move through the process.

For your reference please see included Article XI Special Rules and Regulations of our Bylaws .

ARTICLE XI SPECIAL RULES AND REGULATIONS

Section I: The following rules and regulations shall apply to guests and visitors in respect to the use of the corporation property

(a) Guests: Guests are defined as individuals using corporate property at the invitation of and in the company of a member. Every guest must be registered upon a register provided by the Secretary, showing name and address of the guest, his or her home club, if any, and the name of his or her sponsor. Guests must be accompanied by a member at all times.

(b) Visitors: Visitors are defined as members of other private golf clubs, or invitees to tournaments and special events who are not guests of a member. Visitors that are members of other private clubs must be registered upon a register provided by the Secretary, showing the name and address and home club. Such visitor shall also have satisfactory identification verifying such membership.

(c) Use of Corporation Property: Any member of the corporation may invite any guest to use the corporation property, subject to the payment of appropriate fees. Such use shall not exceed the use of the member's specific class of membership and shall be governed by the rules and regulations promulgated by the Board of Directors and approved by the general membership. Visitors, not the guest of a member, subject to such aforementioned rules, shall, upon payment of the appropriate fees, be entitled to play golf and to the privileges of the clubhouse and grounds.
